Medicare Recognized Helicoll as a High-Cost skin substitute Continuously since 2017

Medicare has confirmed the recognition of Helicoll (Q4164) as a high-cost skin substitute with relevant Supportive Codes. This fact has not been properly captured in most software systems. We urge all Medical coding and billing software companies to acknowledge Helicoll as a High-cost skin substitute in their systems. Helicoll should be billed in conjunction with CPT codes 15271 – 15278 and should not be billed with HCPCS codes C5271 – C5278. Request to adopt correct coding for Q4164 To All Medical Billing and Coding Software Companies



We request again to all Medical Coding/Billing software system administrators to change the reimbursement info for Helicoll skin Substitute with Q4164 code as follows as prescribed by Medicare:

Q4164 Code Tips: “Helicoll™ has been assigned to the high-cost skin substitute group continuously since 2017. Helicoll should be billed in conjunction with CPT codes 15271 – 15278 and should not be billed with HCPCS codes C5271 – C5278. There is no separate payment for Helicoll in the OPPS. The assignment to the high-cost skin substitute group means the product will be packaged with procedures in the CPT code range of 15271 – 15278 and those procedure codes are assigned to an APC category.”
